Timing

There are three deadlines: january 30th; june 30th ; november 30th

Following the transmission of the proposal, the Editorial board components of the relevant area will proceed, autonomously or through the support of external scientists, to evaluate the proposal.

As a result of this first evaluation, executed within one month from the date in which the proposal is received, and if the proposal is accepted, the author is contacted to agree on a date for the final manuscript delivery and for some suggestions about the final organization of the text. If the author accepts to prosecute his work, will have to send within the agreed date the final manuscript.

The editor entitled of the review will send the manuscript to two or more referees for peerreview.

Within three months, the referees will tell the editor of the relevant area the comments; the authors will then be invited to modify the manuscript accordingly. The corrected manuscript will be further reviewed and a final evaluation about acceptance will be given. From that time on, the author will be guided along the final publishing process

The editorial products are all in english language. For this reason the editor invites the authors that are not native english to use the editing services also offered by EDANZ, http://www.edanzediting.com/. The latter is however an independent structure and there is therefore no connection or constraint about the choice on editing services.
