Il Programma "Rights, Equality and Citizenship 2014-2020" tutela i diritti e la libertà delle persone, ai sensi della legislazione europea.

In particolare:

- promuove la lotta alla discriminazione;
- combatte il razzismo, la xenofobia, l'omofobia e altre forme di intolleranza;
- promuove la parità e le politiche di genere;
- previene la violenza nei confronti dei bambini, dei giovani, delle donne e di altri gruppi a rischio;
- promuove i diritti dell'infanzia;
- garantisce i diritti di cittadinanza nella UE;
- rafforza i diritti dei consumatori.

Il budget del programma è di 439,5 milioni di euro per il periodo 2014-2020.

Le azioni ammissibili a finanziamento, in grado di dimostrare un chiaro valore aggiunto europeo, sono:

- formazione (scambi di personale, workshops, sviluppo di moduli formativi, ecc.);
- apprendimento reciproco, attività di cooperazione, condivisione buone pratiche, peer reviews, sviluppo di strumenti ICT, ecc.);
- attività di sensibilizzazione, disseminazione, conferenze;
- supporto agli attori coinvolti (ONG e loro reti, autorità presso gli Stati Membri che implementano la normativa europea, ecc.);
- attività di analisi (studi, raccolta dati, sviluppo di metodologie comuni, indicatori, sondaggi, preparazione di linee guida, ecc.).
