

## SHORT ANNOUNCEMENT

*Public selection, by qualifications and public interview, for recruiting n. 1 researcher with a fixed-term - full-time employment, pursuant to the art. 24 paragraph 3 letter a) of the Law n. 240/2010 in the text in force prior to the entry into force of Law no. 79/2022 converting Decree Law no. 36/2022, for the Department of Political Science and International Relations (DEMS), financed on the funds of National Recovery and Resilience Plan ACySeM - Assessing Cyber Security Maturity in National and Legal Frameworks: A Multidisciplinary Approach to Protecting National Critical Infrastructures in Italy and Europe. Italian Disciplinary Scientific Area - GSPS-03/B – History of political institutions.*

### **Application deadline:**

The application must be completed not later than 12 noon of the twentieth day following the publication of the Italian version of the Call on the official university bulletin board.

### **Admissions requirements:**

Participation is open to applicants with an academic PhD qualification or equivalent, obtained either in Italy or abroad, and/or with a medical specialization diploma for the concerned sector.

In the event of a PhD obtained abroad, candidates must include, under penalty of exclusion, the statement of equipollence with the Italian PhD title pursuant to art. 74 of D.P.R. 382/1980, or the statement of equivalence with the Italian PhD title pursuant to art. 38 of Legislative Decree N.165/2001

### **How to apply**

Applicants must submit their application form, under penalty of exclusion, online, using the online application form available on the following webpage: <https://pica.cineca.it/unipa/>

The candidate will be able to access the competition platform using the SPID system (Public Digital Identity System), selecting the University of Palermo among the institutions or the candidate will be able to register and access using credentials issued directly by the platform or authenticate with his/her LOGINMIUR, REPRISE or REFEREES account, if in possession. The computer application will require the possession of an e-mail address in order to register to the system.

Applicants must enter all the data required to produce the application form and attach the documents in PDF format.

The application form must be completed in all its parts, as indicated in the online procedure.

Other methods of sending application forms or documentation useful for participation in the procedure are not allowed.

The computer application allows applicants to save the documentation entered in draft mode, within the deadline for submitting the application.

The date of the electronic submission of the application is certified by the information system by means of a receipt, which will be automatically sent by e-mail when the application is submitted.

Once the application has been completed and all the attachments have been enclosed, the candidates must click on the "submit" button ("presenta"). The completion of the application will be proven only by the change in the status of the application, which will appear "submitted" ("presentata") and no longer "in draft" ("in bozza").

Upon expiry of the deadline for submission, the system will no longer allow access and sending of the online form.

Each application will be assigned an identification number which, along with the competition code indicated in the computer application, must be specified for any subsequent communication.



The procedure for completing and sending the application electronically must be completed no later than 12 noon of the twentieth day following the publication of this notice on the official university bulletin board.

In case of access through identification through the SPID system, the application for admission to the selective procedure will be automatically acquired by the system without the need for a signature.

In other cases, under penalty of exclusion, the application form must be signed, must contain all the required data and be accompanied by a valid identification document.

The application can be signed with a CADES certified digital signature. Otherwise, candidates must save the PDF file generated by the system on their computer and, without modifying it in any way, print it and add a complete handwritten signature on the last page of the printout. This complete document must be scanned and uploaded to the computer system in PDF format.

**Candidates need to attach the following:**

- a) their scientific-professional curriculum vitae including a list of publications and qualifications;
- b) a copy of a valid identity document;
- c) the scientific publications submitted for assessment, already published by the deadline of this public notice, numbered in an attached dated and signed list (the number of publications must not exceed the number foreseen in the annex referred to in art. 1 of this notice), along with a statement about the sending and deposit of what foreseen in art. 5 of the Italian version of the call regarding publications;
- d) scientific publications submitted for evaluation;
- e) PhD thesis

Please note that only the Italian version of the call is legally binding; this short announcement is provided for general information only.
