#### SHORT ANNOUNCEMENT

Selective procedures related to the filling of 6 positions of university associate professor, to be filled by call, pursuant to Article 18, paragraph 4, of Law 240/2010, at various Departments.

Please refer to Annex 1 for specifications and details of the aforementioned position.

## Application deadline:

The application must be completed not later than 12.00 noon on the thirtieth day following the publication of the Italian version of the Call on the official university bulletin board.

### Admissions requirements:

Only candidates who, in the last three years, have not held a position as a tenured full professor, tenured associate professor, permanent researcher, fixed-term researcher RTT, RTDA or RTDB at the University of Palermo, and who have not held research grants or enrolled in university courses at the same University or called according to Article 7, paragraph 5-bis of Law 240/2010, may participate in this selection procedure.

Furthermore, candidates must meet one of the following requirements:

- a) scholars who have obtained the Italian national scientific qualification pursuant to Article 16 of Law 240/2010 for the disciplinary sector subject to the competition or for one of the disciplinary sectors included in the same macro-sector and for the functions subject to the procedure, or for higher functions, provided they are not already holders of the same higher functions:
- b) candidates who have obtained eligibility in the disciplinary sector in competitions activated pursuant to Italian Law No. 210/1998 for the corresponding band, limited to the duration of such eligibility;
- c) professors already in service at other Italian universities for the disciplinary sector and for the same position corresponding to that for which the call is issued;
- d) scholars permanently engaged abroad in research or teaching activities at university level in positions equivalent to those subject to the call, based on correspondence tables updated every three years, defined by the Ministry.

In the event of a PhD obtained abroad, candidates must include, under penalty of exclusion, the statement of equipollence with the Italian PhD title pursuant to art. 74 of D.P.R. 382/1980, or the statement of equivalence with the Italian PhD title pursuant to art. 38 of Legislative Decree N.165/2001

#### How to apply

Applicants must submit their application form, under penalty of exclusion, online, using the online application form available on the following webpage: https://pica.cineca.it/unipa/

The candidate will be able to access the competition platform using the SPID system (Public Digital Identity System), selecting the University of Palermo among the institutions or the candidate will be able to register and access using credentials issued directly by the platform or authenticate with his/her LOGINMIUR, REPRISE or REFEREES account, if in possession. The computer application will require the possession of an e-mail address in order to register to the system.

Applicants must enter all the data required to produce the application form and attach the documents in PDF format.

The application form must be completed in all its parts, as indicated in the online procedure.

Other methods of sending application forms or documentation useful for participation in the procedure are not allowed.

The computer application allows applicants to save the documentation entered in draft mode, within the deadline for submitting the application.

The date of the electronic submission of the application is certified by the information system by means of a receipt, which will be automatically sent by e-mail when the application is submitted.

Once the application has been completed and all the attachments have been enclosed, the candidates must click on the "submit" button ("presenta"). The completion of the application will be proven only by the change in the status of the application, which will appear "submitted" ("presentata") and no longer "in draft" ("in bozza").

Upon expiry of the deadline for submission, the system will not longer allow access and sending of the online form.

Each application will be assigned an identification number which, along with the competition code indicated in the computer application, must be specified for any subsequent communication.

The procedure for completing and sending the application electronically must be completed no later than 12.00 AM on the twentieth day following the publication of this notice on the official university bulletin board.

In case of access through identification through the SPID system, the application for admission to the selective procedure will be automatically acquired by the system without the need for a signature.

In other cases, under penalty of exclusion, the application form must be signed, must contain all the required data and be accompanied by a valid identification document.

The application can be signed with a PADES/CADES certified digital signature. Otherwise, candidates must save the PDF file generated by the system on their computer and, without modifying it in any way, print it and add a complete handwritten signature on the last page of the printout. This complete document must be scanned and uploaded to the computer system in PDF format.

### Candidates need to attach the following:

- a) their scientific-professional curriculum vitae including a list of publications and qualifications;
- b) a copy of a valid identity document;
- c) list of scientific publications to be evaluated, already published by the deadline of the call, numbered, dated, and signed (the number of publications specified in Annex 1 of this call must not be exceeded), accompanied by a declaration attesting to the deposit as required by Article 5 of the call regarding publications.
- d) scientific publications submitted for evaluation;
- e) a copy of the bank transfer as proof of the participation's contribution.

Please note that only the Italian version of the call is legally binding; this short announcement is provided for general information only.
