Obiettivi del corso.

Il corso si focalizza sul processo di peer-review nel contesto delle comunità accademiche e della pubblicazione sulle riviste internazionali che utilizzano un processo di revisione fra pari (peer-review).

Il corso è suddiviso in 3 moduli che si svolgeranno durante un periodo complessivo di un giorno e mezzo.

In particolare, il corso si propone di:

- **Modulo A – Reviewing papers:**

comprendere come si esegue la revisione di un lavoro scientifico e come sviluppare specifiche abilità per eseguire revisioni di qualità;

- **Modulo B – Addressing editor and reviewer concerns:**

comprendere le fasi del processo alla base della pubblicazione di articoli su riviste internazionali che utilizzano un processo di peer-review e le modalità di partecipazione in modo consapevole a tale processo. In tale contesto, si illustreranno:

i criteri che guidano la prima fase della scelta dell'editor (i.e. desk reject o invio ai revisori); le tecniche, utili per rispondere efficacemente all'editor e ai revisori in caso si riceva una invito a Revise and Resubmit (R&R) il proprio lavoro scientifico;

- **Modulo C – Publishing high quality empirical research:**

illustrare taluni rilevanti metodi di ricerca qualitativa e quantitativa, le principali sfide per la pubblicazione delle ricerche empiriche (qualitative e quantitative), e le tecniche che possono valorizzare il rigore scientifico del lavoro proposto.

Relatori

prof. Andrea Cipollini, is Associate Professor of Econometrics at the Department of Economics, Management and Statistics of the University of Palermo. Before moving to Palermo, he taught at Queen Mary University of London, University of Glasgow, University of Essex, University of Modena and Reggio Emilia. His research interests regard empirical analyses of financial fragility. In particular, he has studied credit risk (through the application of dynamic factor models), the sustainability of public debt (using non linear regression models), the main determinants of a currency crisis and of financial contagion (by indentifying simultaneous equation models through heteroschedasticity). He has been the principal investigator of the "Real and financial economic dynamics in a globalized word: Theory, Modelling, and Policy Implications" project during his period at the Economics Department of the University of Modena and Reggio Emilia. His research has been published in numerous international journals, among which Journal of International Money and Finance, Journal of Empirical Finance, Journal of Banking and Finance, Economic Inquiry.

prof. Livan Fratini is Professor of Manufacturing at the University of Palermo. His scientific activity has been mainly focused on the development of numerical models and experiments for the analysis of the plastic behaviour of metals during forming and joining by forming processes. He has been involved in several research projects, and is coauthor of about 300 papers in international scientific journals or in the proceedings of international conferences. He is Associated Member of CIRP (he won the Taylor medal in 2007) and Secretary of the Board of Directors of ESAFORM. Prof. Fratini serves also in the Board of Directors of North American Manufacturing Research Institution of SME. Finally Prof. Fratini is Vice-President of AITEM - Associazione Italiana Tecnologia Meccanica.

Prof. Francesco Lo Piccolo, is Professor of Urban Planning and Coordinator of the PhD Programme in the Department of Architecture at the University of Palermo. He was a Fulbright Fellow and a Marie Curie TMR Fellow. His research is mostly directed to social exclusion, ethnicity and diversity, conflicts and power relationships in planning, with specific interests in ethics and justice. He is editor (with Huw Thomas) of the book Ethics and Planning Research (2009). He is member of the editorial board of Town Planning Review. He is the President of AESOP, Association of European Schools of Planning for the period 2014-2016.

prof. Arabella Mocciaro Li Destri is Associate Professor of Management at the Department of Economics, Management and Statistics of the University of Palermo. She gained her PhD in Business Economics and Management at the University of Catania. She has been visiting scholar at the Sloan School of Management - Massachussets Institute of Technology, and visiting professor at the Tuck School of Business at Dartmouth and at IAE

Business School, Universidad Austral, Buenos Aires. Her research interests regard: knowledge dynamics in strategic interfirm networks, strategic interfirm network evolution and governance, the relationship between the firm and its institutional environment, and the management of corporate scandals. She sits on the editorial boards of the American Journal of Business, Unipa-Springer Series and in the Scientific Committee of Busyness Systems Laboratory Series. Amongst others, she has reviewed for journals such as Strategic Management Journal, Long Range Planning, Regional Studies, Journal of Managerial Psychology and Advances in Strategic Management.

prof. Davide Ravasi obtained his PhD in Business Administration at the Bocconi University in Milan. Currently he is Professor of Strategic and Entrepreneurial Management at the Cass Business School, London, where he is the Coordinator of the PhD programme in Management. His research examines the relationship between organizational identity, culture and strategy in change processes; and the way objects influence sensemaking processes. More generally, he is interested in the cultural processes that influence the genesis and the diffusion of new objects and practices, and their adoption by individuals and organizations. His research has been published on various international journals, such as: Academy of Management Journal, Organization Science, Journal of Management Studies, Journal of Business Venturing, Industrial and Corporate Change, e Organizational Dynamics. He is one of the editors of the forthcoming Oxford Handbook of Organizational Identity.
