The forms attached to this call for applicants, one for each course, indicate the research topics, the restricted topics required by the funder and the curricula (if any) into which the course is divided, the required admission qualifications and the relevant degree classes.

All scholarships, financed by an external body, shall be paid to the grantees subject to the actual receipt by the University of the relevant sums.

A DDR course may not be activated if one of the following conditions occurs:

- the course will not be accredited by the MUR;
- less than four applications are received;
- at any step of the competition procedure, less than four candidates are present. In this case, the selection board will take note of the preclusion of the course and will notify the candidates present;
- at the end of the selection procedure, there will be less than four candidates in the ranking (Ministerial Decree 226/2021, Art. 4, paragraph 1, letter b, number 1).

The date, position and time of the tests will be published on the website www.unipa.it/didattica/dottorati and this publication will have the value of notification for all purposes; candidates will therefore not receive any written communication regarding the date and venue of the tests.

The positions with scholarships referred to in this notice may be increased and/or financed as a result of further available funds, also obtained from external public or private bodies, through agreements or conventions to be entered into after the issue of this notice and in any case within six months from the start of the PhD courses.

Any other scholarships that may become available within the framework of research projects financed by National Operational Programmes, Regional Operational Programmes, other Community, National and Regional Programmes and/or International Projects, may be used in addition to the scholarships financed by the University. In addition, eligible candidates who were awarded, on the date of expiry of the call for applications, European Commission Grants of a gross amount equivalent to or greater than the PhD scholarship, at the end of the competition procedure, may be admitted, at their request, to the course on a surplus position.

Art. 2 Scholarships D.M. n. 351 - TDA-PA-PC-PNRR

The grants referred to Art.1, identified by the acronym DM 351, were assigned by Ministerial Decree no. 351 of 09/04/2022 to the University of Palermo, in accordance with the PNRR, Mission 4, Component 1 "Enhancement of the supply of education services: from kindergartens to the University" - Investment 3.4 "Advanced university teaching and skills" and Investment 4. 1 "Extension of the number of PhDs and innovative PhDs for public administration and cultural heritage", number of 69 three-year doctoral scholarships for attending PhD pathways, cycle XXXVIII, Academic Year 2022/2023, to develop research topics linked to the following macro-areas:

- "Digital and Environmental Transition", identified within this call for applications by the code [TDA];
- "Public Administration", identified within this call for proposals by the code [PA];
- "Cultural Heritage", identified within this call for proposals by the code [PC];
- themes of the PNRR plan, identified within this notice by the code [PNRR] and must fall within the following missions:
- 1. Digitalisation, innovation, competitiveness, culture and tourism;
- 2. Green revolution and ecological transition
- 3. Infrastructure and sustainable mobility;
- 4. Education and research;
- 5. Social, gender and territorial equity;
- 6. Health.

Each DM 351 grant will be co-funded for € 60,000 by the MUR and will only be awarded following approval of the funding by the Ministry of University and Research.

In the event that the candidate also intends to compete for one of the DM 351 grants, he/she must compulsorily tick one of the options, TDA, PA, PC, PNRR, in the DM 351 section of the project form (Annex B). Candidates competing for one of these posts will also apply for the award of unrestricted posts.

positions with scholarships pursuant to Ministerial Decree no. 351 of 9 April 2022 are advertised subject to approval of ministerial funding. Doctoral scholarships are activated within the scope of the restricted topics indicated in the aforementioned decree and in compliance with the eligibility criteria set out in Articles 6, 7, 8 and 9 of M.D. 351.

Art. 3 Scholarships D.M. n. 352 - PNRR and IMPRESE

The grants referred to in Art.1, identified with the initials DM 352, have been assigned by Ministerial Decree no. 352 of 09/04/2022 to the University of Palermo, under the PNRR, Mission 4, Component 2 "From Research to Enterprise" - Investment 3.3 "Introduction of innovative doctorates that respond to the innovation needs of enterprises and promote the recruitment of researchers from enterprises", resources for the funding of scholarships for innovative doctorates cycle XXXVIII, Academic Year 2022/2023, to develop research topics linked to the following PNRR macro-areas

- 1. Digitalisation, innovation, competitiveness, culture and tourism;
- 2. Green revolution and ecological transition;
- 3. Infrastructure and sustainable mobility;
- 4. Education and research;

5. Social, gender and territorial equity;

6. Health.

The scholarships in this article are subject to a binding theme and are financed 50% by the MUR and 50% by companies. In the PhD forms, these grants are identified by the code PNRR.<code>.

In the event that the candidate intends to compete for a DM 352 bursary, he/she must obligatorily indicate in section DM352 of attachment B (Project form), the PNRR.<code> code indicated in the PhD form. Candidates who compete for one of these posts will also compete for the award of unrestricted posts.

positions with a scholarship pursuant to Ministerial Decree no. 352 of 9 April 2022 are advertised subject to approval of ministerial funding. Doctoral scholarships are activated within the scope of the restricted topics indicated in the aforementioned decree and in compliance with the eligibility criteria set out in Article 6 of the aforementioned decree.

Art. 4 Admission requirements

1. Qualifications for admission

Candidates may participate in the selection process, without age or nationality restrictions, if they hold one of the following qualifications, belonging to the degree classes specified in the relevant degree form (attached and numbered with the Competition Code as per Art. 1), for which they are applying

- Master's degree (Ministerial Decree no. 509/1999);
- Master's degree (Ministerial Decree no. 270/2004);
- Diploma di laurea Vecchio Ordinamento, equated pursuant to Interministerial Decree no. 233 of 9 July 2009 and ss.mm.ii.

Failure to hold a qualification belonging to one of the degree classes indicated in the doctorate form shall constitute grounds for exclusion from the competition procedure.

Candidates in possession of an academic qualification obtained abroad, of at least four years' duration, equivalent in terms of level of study (Master's Degree) to the Italian qualifications specified above may also participate.

Candidates already in possession of a PhD qualification may also apply for admission to the PhD competition. In this case the candidate, if he/she has previously received a PhD scholarship, even partially, may be admitted to attend the course, in supernumerary number without a scholarship, subject to passing the examination tests and being positiond in the rank list of successful candidates.

All candidates are admitted to the selections with reservations.

If, following verification of the self-certifications produced, the qualification possessed does not comply with the above-mentioned requirements or the declarations produced are untrue, the University may, at any time during the procedure, even after enrolment or commencement of the doctoral course, issue a ruling by the Rector to exclude the candidate from the selection procedure or the doctoral course, without prejudice to the criminal liability arising from false declarations.

2) Admission to selection for candidates in the process of obtaining a degree

Those who obtain the qualification required by the competition notice by the date of enrolment in the PhD course may also apply, under penalty of forfeiture of admission to the course.

Admission to the competition will be subject to conditions and candidates must submit to the Research Doctorates Office, within 10 days of obtaining the qualification, under penalty of forfeiture, a declaration in lieu of certification (or certification in the case of a qualification obtained in a non-EU country) that the qualification has been obtained, in accordance with art. 46 of D.P.R. 445/2000 and subsequent amendments.

3) Academic qualification obtained abroad

Citizens in possession of an academic qualification obtained abroad, following the attendance of a training course lasting at least four years, equivalent in terms of level of study to the Italian academic qualifications required for admission to the PhD course, must enclose with the application form the degree certificate issued by the university of origin; if the same has not already been declared equivalent, the course admission committee shall ascertain the suitability of the foreign qualification, in accordance with Article 2 of Law 148/2002, the regulations in force in Italy and in the country where it was awarded, as well as the treaties or international agreements on the recognition of qualification was awarded, as well as international treaties or agreements on the recognition of qualifications for the pursuit of studies. The suitability ascertained by the commission will be valid solely for the purposes of admission to the competition.

Applicants in possession of degrees obtained in a non-European country, in the event of admission to the course, must produce the aforementioned degrees accompanied by a translation, legalization and "Dichiarazione di Valore in Loco", to be provided by the Italian diplomatic-consular representation with territorial jurisdiction, in accordance with the regulations in force on the admission of foreign students to degree courses at Italian universities.

Foreign qualifications may be replaced by the Diploma Supplement, issued by the competent Institutions in accordance with the standards established by the European Commission and covering the overall course of study leading to the

degree. The University reserves the right to request a "Dichiarazione di Valore in Loco" in cases where there are doubts as to the validity of the degree.

Applicants with a foreign qualification will be admitted to the selection process with reservations and if, following verification, it turns out that the qualification does not comply with the requirements of this call for applications and therefore does not permit enrolment, they will be excluded from the PhD programme.

4) Contribution for participation in the competition procedure

In order to participate in the competition, candidates, in accordance with Board of Directors resolution no. 05 of 11.4.2013, are required to pay a contribution of €50.00, under penalty of exclusion, by the deadline for submitting the application.

The payment, which is not refundable under any circumstances, must be made through the PagoPA service, which can be accessed from the online procedure of the student portal or at any PSP (Payment Service Provider) desk in Italy. For further information, please refer to https://immaweb.unipa.it/immaweb/public/pagamenti.seam.

Those who make the payment of the competition fee by methods other than those described above or outside the terms indicated above will not be admitted to the competition procedure.

Disabled persons with a certified disability of more than 66% and foreign citizens are exempt from payment of the aforementioned fee for participation in the competition procedures (Board of Directors resolution no. 05 of 5.04.2013). Foreign candidates do not have to hold Italian citizenship to be exempt from the competition fee.

Art. 5 Application

In order to apply, candidates have to complete the following online procedure:

Candidates already registered in possession of a username and password may skip directly to point b).
- b) Access the Student Portal http://studenti.unipa.it using your credentials (username and password), click on "Click here to access your Reserved Area".
- c) Select the "New Practice" link from the "PRACTICES" menu at the top. From the proposed list, select the item "PhDs/PhDs" and then the item "Application for admission to a PhD course / PhD Courses Call for applicants".
- d) Fill in the application and pay the participation fee for the competition of € 50.00 (fifty/00), in no case refundable, according to the modalities indicated in art. 2 point 4 above, by the deadline of the call, published at the link: www.unipa.it/didattica/dottorati/

The application to take part in the competition for admission to the PhD courses, filled in online, is valid as self-certification made pursuant to DPR 445/2000 and art. 3 of Law no. 127/97.

The candidate must also attach to the application, by upload, the following documents in pdf format

- 1) (Annex A) Europass Curriculum Vitae;
- 2) (Attachment B) Signed research project. Brief description of the project, its objectives and achievable results.
- In the form the candidate may also indicate whether he/she is also interested in competing for the award of subject-based grants funded by Ministerial Decree 351/2022, by Ministerial Decree 352/2022 or by the University of Palermo.
- For DM 351 grants, the candidate must select only one of the options TDA, PA, PC and PNRR.

For DM 352 bursaries, financed by the MUR and by companies, the candidate must indicate the code of the bursary for which he/she intends to compete as indicated in the doctoral application form (code in PNRR.<code> format.

For University grants with a limited duration, the candidate must indicate the code of the grant for which he/she intends to compete as indicated in the doctoral file (code in the format BA.<code>).

Candidates who choose to compete for a restricted theme scholarship will also automatically participate in the competition for a position with a free research theme. In any case, the research project proposed by the candidate must be consistent with the objectives of the course.

Undergraduates must attach a copy of the examinations they have taken or similar self-certification, issued in accordance with DPR 445/2000.

Undergraduates at foreign universities must attach certification of the examinations taken (in Italian or English), issued by the university of origin.

The following shall constitute grounds for exclusion from the competition procedure:

- failure to hold a qualification belonging to one of the degree classes specified in the doctoral file;
- access qualifications obtained abroad, not equivalent in terms of level of study (Master's Degree) to the access

Art. 7 Admission tests

1. Selection procedures

The modalities of the selection are indicated, for each PhD, in the individual PhD course sheets which are an integral part of this notice.

The competition will take place by **project evaluation**, **qualifications and interview**.

The **interviews** are public and will be held electronically, through Microsoft Teams.

Each candidate may participate in the selections for more than one PhD, by submitting separate applications; this circumstance, however, shall not constitute a constraint on the timetable of the tests.

In the case of Research Doctorates divided into curricula, each candidate shall indicate in the online application one or more curricula, according to the order of priority in which he/she is interested. The curricula are indicated in the attached forms, each relating to an individual PhD.

2 Evaluation criteria: project, qualifications and interview

Scientific publications: Points 1 (max 3 points); will be evaluated only published documents before expiring date of the announcement, which will be relevant to the objectives of the course and provided with ISBN, ISSN, ISMN or DOI.

Titles - maximum 10 points

- For the assessment of qualifications, each Commission will use the following criteria:

Title of admission to the competition: Points 0

Other university degree: 0.5 points (max 1 point)

PhD qualification: Points 1 (max 2 points)

Certificate of postgraduate university courses: Points 0.5 (max 1 point)

Attendance of specialization schools recognised by the MUR: Points 0.2/year (max 1 point)

2nd level university Master's degree recognised by the MUR: Points 0.5 (max 1 point)

Post-graduate periods spent at Italian or foreign scientific institutions: Points 0.1/month (max 3 points).

Scientific publications: Points 1 (max 4 points), only publications published on the date of expiry of the call for applications, which are relevant to the objectives of the course and have an ISBN, ISSN, ISMN or DOI will be evaluated.

The maximum total score awarded to qualifications and scientific publications may not exceed 10 points. Scores above 10 will be considered equal to 10.

The evaluation of the titles shall be carried out before the oral test takes place, with a document attached to the minutes.

Interview - maximum 60 points.

The test is considered passed with a minimum mark of 31/60.

Eligible candidates graduated abroad and successfully passed the examinations, if they are not among the successful candidates, shall be admitted to the PhD course, without a scholarship on a surplus position, to the extent of 50% of the positions available, pursuant to art. 10 point 9) of the Regulation of the PhD courses, after having obtained the necessary opinion of the Board of PhD teachers, only if

- they are recipients of scholarships funded by the Ministry of Foreign Affairs and International Cooperation (MAECI) of the Italian Republic or by the Government of their country of origin
- they belong to countries with which there is a specific intergovernmental agreement or convention with the University or in any case at no cost to the University itself.

Holders of research grants, as per Art. 22 of Law 240/2010, published on 14.01.2011, who are winners, may apply for enrolment in the PhD programme as winners, renouncing the grant, or apply for supernumerary enrolment without a grant, no more than one, according to the order of the general merit list, without renouncing the grant, subject to payment of the fees for access and attendance. The option is irrevocable.

Those who, by the deadline for enrolment, are successful in a selection process for the award of a research grant, the contract for which will begin at the same time as the start of the courses, must declare this in their application.

Art. 12 Enrolment Procedure

Successful candidates must complete the online registration process within the peremptory deadline of 7 days, starting from the day after the publication of the rankings on the website: www.unipa.it/didattica/dottorati/

According to the instructions that will be published on the aforementioned University website, by accessing the Student Portal (http://studenti.unipa.it) with the same credentials obtained during registration, it will be possible to complete the "Application for Enrolment in a PhD programme" online, which can be accessed through the hypertext path PRATICHE STUDENTE - NUOVA PRATICA - Dottorati di Ricerca. b) For applicant admitted as supernumerary, without grant:

Regional Tax: € 140.00
Additional government Tax € 16,00

Are exempted from the payment of admission fees:

- holders of "student loan" and also people with disability level superior to 66%;
- holders of research grant financed by the Ministry of Foreign Affairs, as regards to the year of the financed research grant;
- foreign applicants who are holders of research grants financed by their country of origin. In any case, Doctoral students will have to pay the regional taxes for the 'right to education'.

Art. 14 Grants / Scholaships

The available scholarships will be allocated according to the order of the ranking list, until they are exhausted.

Scholarships financed by other institutions will be assigned after those financed by the University according to the order of the ranking list, unless otherwise established by the Board of Lecturers.

In the event of equal merit, the candidate with the youngest age shall prevail.

Under no circumstances, following withdrawals or exclusions, may the residual grant be transferred to another doctoral student once the course has begun.

The amounts of the secretarial fees or the regional fee may vary from year to year, following a resolution of the Academic Bodies or Ministerial or Regional provisions.

Those who have been awarded a scholarship for a PhD course, even for only one year or part of a year, may not apply for it a second time and shall be positiond among the winners without a scholarship.

The annual amount of the grant is €16,243.00 (Ministerial Decree no. 247 of 23 February 2022) gross of social security charges payable by the PhD student and is subject to INPS social security contribution under separate management.

The grant may in any case be paid only after the doctoral student, at the time of enrolment, has communicated his/her bank details (IBAN); for the purposes of payment, the Italian or foreign bank account must be in the name of the declarer.

The doctoral student must be in possession of a valid tax code and enrolled in the Separate Account at the National Social Security Institute (INPS);

The duration of the scholarship is annual and is renewed on condition that the doctoral student has completed the programme of activities planned for the previous year and has been admitted to the following year by the Board of teachers.

The frequency of payment of the scholarship is monthly in arrears.

The amount of the scholarship is increased by 50% in proportion to and in relation to periods of training abroad provided for in the training plan; this increase may not be paid for a period exceeding eighteen months.

Supernumerary PhD students without a grant who go abroad will be eligible for a grant in accordance with Art. 16, paragraph 6 of the Regulation of PhD Courses.

In the case of a grant financed by an external body, the periods of training abroad will be governed by the terms of the grant and the relative agreement.

Failure to finalise the agreements with external bodies for the funding of scholarships by 31/12/2022 shall result in the non-allocation of the scholarships, even if indicated in the PhD course outlines attached to this notice.

The provisions on tax benefits as per Art. 4 of Law no. 476 of 13.8.1984 and Art. 6 point 6 of Law no. 398/89 shall apply to scholarships for course attendance.

For the entire duration of the course, doctoral students, under penalty of forfeiture of the course, are not allowed to combine their scholarship with others of any kind, except with those granted by national or foreign institutions useful for integrating the training or research activities of scholarship holders with stays abroad (art. 6 of Law no. 398 of 30 November 1989).

Art. 15 Attendance and obligations

Admission to the PhD programme entails an exclusive full-time commitment, in accordance with the Regulation of PhD courses at the University of Palermo.

Doctoral students are required to carry out their curricular activities in accordance with the procedures and times established by the Board of teachers, in compliance with the training plan defined in the activation proposal, with the exception of the provisions of art. 12 of Ministerial Decree no. 226 of 14/12/2021.

At the end of each year of the Course the doctoral students must submit a report on the progress of their research to the Board of teachers. The Board may request the doctoral students to prepare interim reports and/or reports in order to assess their training.

The Board of teachers decides on admission to the following year or, in the event of a negative assessment, on exclusion from the course.

Exclusion from the course is not permitted in cases of maternity or serious and documented illness.

In the event of an unjustified suspension, lasting more than thirty days, the grant cannot be awarded and the period of suspension is not subject to recovery.

In compliance with article 14, point 3) of the Regulation of PhD courses at the University of Palermo, "PhD students may carry out, as an integral part of their training project, with the prior authorisation of the doctoral board and without increasing the amount of the scholarship, tutoring activities, including paid tutoring, for students on degree and master's degree courses, as well as, within the limit of forty hours per academic year, supplementary teaching activities. For the activities referred to in this paragraph, doctoral students are paid the allowances referred to in Article 1, paragraph 1, letter b) of Decree-Law no. 105 of 9 May 2003, converted, with amendments, by Law no. 170 of 11 July 2003".

Doctoral students in the medical area may participate in clinical-assistance activities.

In the case of doctorates established as a result of international inter-university cooperation, the modalities of the course, the awarding of the degree and the final commission are defined according to the provisions of the agreements themselves. PhD students who are awarded a PhD scholarship are obliged to be enrolled in the separate management scheme.

Art.16 Inelegibility

Enrolment on the doctoral course is incompatible with enrolment in Italy and abroad in other study courses, doctoral courses, degree courses, specialised/master's degree courses, 1st and 2nd level university master's degree courses, postgraduate courses equated to master's degrees, specialisation schools (excluding medical schools referred to in Article 8 above), with the exception of co-thesis agreements and international doctorates that provide for dual enrolment.

Art. 17 Awarding of the Doctorate

The title of PhD, abbreviated as "Dott. Ric." or "Ph.D.", is awarded following the positive evaluation of a research thesis that contributes to the advancement of knowledge or methodologies in the chosen field of investigation. The doctoral thesis, accompanied by a summary in Italian or English, is written in Italian or English or in another language subject to the authorisation of the board of teachers. At the end of the discussion, the Commission formulates a detailed judgement, which takes into account the judgements expressed by the Board of Lecturers for admission to the following years and to the final examination.

The PhD title is awarded upon passing the final examination, to be taken before a special Commission set up in accordance with Article 16 of the "Regulation of PhD Courses" of the University of Palermo, after being admitted to the final examinations by the Board of Lecturers at the end of the third year of the course, upon payment of an admission fee and the stamp duty required by law.

The University takes care of the deposit of the thesis at the national libraries of Rome and Florence, through the IRIS application for Research, and at the same time guarantees its public consultation on the web.

The title of PhD is conferred by the Rector, who certifies its achievement by issuing a parchment.

Art. 18 Data Protection Act

The Administration of the University of Palermo, in accordance with Legislative Decree n.196/2003 and subsequent amendments, will respect the confidentiality of information supplied by the candidate.

The applicants' personal data will be used only for selection procedure, institutional purposes and possible career management of the PhD Student, until the obtainment of the title of Doctoral Researcher, in accordance with the provisions in force.
