CALL FOR PROPOSALS TO PARTICIPATE AT THE FIRST EDITION OF THE TRAINING IN "EXPERT PRACTITIONERS ON VIOLENCE OF PROXIMITY"

It is open the selection criteria of the first two editions of the training PROVIDE (PRoximity on VIolence: Defence and Equity), financed by the European Commission (*Rights, Equality and Citizenship Programme* (2014-2020). The training aims at specializing 50 professionals, experts on the identification and accompaniment of refugees/asylum seekers, victims of proximity violence during the travel, until reaching the Italian and European coasts. The following editions will take place in Palermo, Agrigento, Florence, Paris and Jaén.

The standardization of the asylum system has highlighted the *lacunae* on the specific assistance of the asylum seekers with particular vulnerabilities, as previewed by the art. 17 of the Directive 2013/33/EU. In Italy, an approach discrepancy emerged regarding the violence of proximity and a disparity among the care services activated in the several Southern and Northern regions. The launch of services regarding the registered violence cases is mainly correlated to the adoption of a gender mainstream that is limited to the sending of the victims to anti-violence centres and to the anti-trafficking referents. This limitation highlights subsistent gaps regarding the assistance of migrants with particular necessities.

The violence suffered by the migrants in the transit countries is mainly detected by the practitioners that work within the Hotspot, CAS, SPRAR as gender violence, neglecting the consequences of a wide category of violence of proximity and the number of cases.

The course, divided into 5 modules of five hours each (as in the attachment n. 1), has the aim of preparing a selected group of "expert practitioners on violence of proximity".

It is previewed a full attendance.

The selection criteria of the attendants will be carried by the designated commission, chaired by the Professor Ignazia Bartholini, the project manager of the project.

The course previews a full attendance.

For the participation, it is required:

- 1. A Master Degree (or an old study four-year diploma) in Social Services, Psychology, Educational Sciences or Pedagogic Sciences; Foreign Languages and Literature, Law and, subordinately, a three-year degree.
- 2. Professional experience regarding the degree in a Hotspot, CAS, SPRAR in the last five years (2013-2017), for at least two years.
- 3. Other professional titles (for instance, management of a Hotspot, CAS or SPRAR) and Academic titles of equal or superior level (for instance, second Master degree or second level Master on the migration phenomenon) will be evaluated.

In case of equal score, the commission will choose the youngest applicant.
