8. INFORMATION ON THE NATIONAL HIGHER EDUCATION SYSTEM

8.1. Access to the higher education

The total duration of education until completion of a school which offers the possibility of taking the secondary school leaving examination (maturity examination) is 12 - 15 years. Having passed successfully the secondary school leaving examination (maturity examination), graduates are awarded a secondary school leaving certificate (maturity certificate) which entitles them to apply for addmission to a higher education institution.

8.2. Higher education system

Higher education system in Poland and the basis for its operation are laid down in the Act of 27 July 2005 - Law on Higher Education (Journal of Laws No 164, item 1365, as amended). Its provisions are applied both to state (public) and non-State (non-public) higher education institutions, in which programmes of study are offered on the same basis and upon completion of the same requirements. Higher education institutions are divided, irrespective of their status, into academic and vocational ones. An academic higher education institution is a school in which at least one of its organisational units is entitled to award the academic degree of *doktor*.

A vocational higher education institution is a school offering first or second cycle study programmes or one-tier (long-cycle) study programmes, as well as doctoral (third-cycle) programs.

First-cycle programmes leading to *licencjat degree* last from 6 to 8 semesters while those leading to *inżynier degree* last 7 or 8 semesters.

Second-cycle programmes last 3 or 4 semesters while one-tier (long-cycle) programmes last from 9 to 12 semesters. Higher education programmes and doctoral programmes may be offered as full-time or part time programmes.

8.3. Degrees awarded o graduates of higher education institutions

- licencjat, licencjat pielęgniarstwa or licencjat położnictwa, inżynier, inżynier pożarnictwa, inżynier architekt or inżynier architekt krajobrazu awarded to graduates of first cycle programmes;
- magister and equivalent degrees of: magister sztuki, magister farmacji, magister inżynier, magister inżynier architekt, magister inżynier architekt krajobrazu, magister inżynier pożarnictwa, magister pielęgniarstwa, magister położnictwa, lekarz, lekarz dentysta, lekarz weterynarii.

8.4. ECTS

The number of the ECTS credits provided by the plan of studies for one semester is from 27 to 33, while it is 60 ECTS credits for an academic year. It is necessary to gather 180 - 240 ECTS credits to complete a first cycle programme, 90 - 120 ECTS credits to complete a second cycle programme, and 270 - 360 ECTS credits to complete a one-tier (long-cycle) programme.

8.5. Academic degrees, degrees in arts, academic title, academic title in arts

In accordance with the Act of 14th March 2003 on academic degrees and academic title and degrees and title in arts (Journal of Laws No 65, item 595, as amended) the academic degrees, degrees in arts and the academic title of profesor are awarded.

The academic degrees are the degrees of doktor and doktor habilitowany of a specific area of science in a given scientific discipline.

The degrees awarded in arts are the degrees of doktor and doktor habilitowany of a specific area of arts in a given artistic discipline.

Academic degrees are conferred by organisational units of higher education institutions, Polish Academy of Sciences and research and development institutions in compliance with the powers granted under a separate procedure.

The academic title is the degree of *profesor* of a specific area of science, while the equivalent degree in arts is the degree of *profesor* of a specific area of arts. The degree of profesor is conferred by the President of the Republic of Poland.
