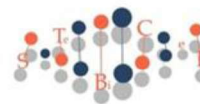

Basis of the agreement

The basis of the agreement is the desire to undertake mutual cooperation regarding the exchange of scientific and cultural ideas between the two Universities, representing culturally and geographically different regions of the European Union. The agreement is intended to prepare conditions conducive and facilitating cooperation between scientists of the two Parties and mutual support in various areas of science and research. In the context of the premise thus outlined in the agreement, the Parties, wish to establish fruitful cooperation and agree on the following points:

§ 1

The Parties declare their willingness to cooperate in scientific areas:

- joint research in the area of broadly defined public health, physical activity, sports biology, etc. joint publication of scientific results obtained in prestigious scientific periodicals
- applying for scientific and research grants to various institutions that support scientists in their research, including national, international and European Union institutions
- substantive support of the journal Human Movement and others areas of cooperation not defined in this document

§ 2

The parties will implement cooperation in the following forms:

- joint scientific projects;
- scientific internships;
- conferences, symposia, workshops and face-to-face meetings, etc.

§ 3

This Agreement has no financial implications for either Party.

Individual projects will be implemented under separate written agreements.

§ 4

If necessary, the Parties may enter into other Agreements consistent with this document and current needs.

§ 5

This agreement is concluded for an indefinite period of time. The Parties may terminate this agreement upon giving appropriate notice to the other Party.

The Agreement shall expire after three months from the date of delivery of such notice.

The Agreement has been drawn up in duplicate, in English and Polish having identical force.
