Model European Union is a simulation of the legislative process in tourism in the European Union. Participants take roles as Ministers of the Council of the European Union or as Members of the European Parliament, even Councelors/ministers of each Public Administration or Power involved in legislative/executive procedure in tourism. Furthermore, two experienced participants become European Commissioners and each presents a directive proposal to the chambers, which will be discussed and amended during the simulation. The directive proposals are chosen by the organisation team and are usually proposals, which have been discussed in the European Institutions in Brussels and Strasbourg. We have not yet made the final decision on the proposals.

Our proposal, following a study of tourism regulation in the spheres of the European Union, the Spanish State and the State of the entity or entities with which this project is shared, as well as the Communities and intra-national Entities with competence in this field of tourism, aims to analyse the situation of tourist accommodation, both from private law and from public law. The new forms of tourist accommodation generate a significant legal problem, which is projected onto other areas such as Competition Law or Urban Planning Law, as well as the new possibilities offered by the forms of collaborative economy through the transfer of private dwellings. The various Member States have similar problems, which is why it is interesting to look at these issues in a comparative way.


