INFORMATION ON THE PROCESSING OF PERSONAL DATA

1. Data controller

The Data Controller is the University of Palermo, located at Piazza Marina n. 61, 90133 - Palermo (e-mail address: rettore@unipa.it, PEC address: pec@cert.unipa.it).

2. Data Protection Officer

At the University there is a Data Protection Officer, appointed in accordance with Article 37 of the EU Regulation - e-mail address: dpo@unipa.it - PEC address dpo@cert.unipa.it.

3. Sources and types of data

The personal data that may be processed, exclusively for the purposes indicated in paragraph 4, are:

- (a) personal data (first name, last name, place and date of birth) and contact data;
- (b) career data and professional training data.

4. Purpose of processing

Expressions of interest and related personal data are collected and processed by the University only for the purpose of planning any subsequent recruitment procedures, in the three-year period 2023-25, reserved for external faculty.

Expressions of interest, received in response to the notice, will be transmitted to the Departments of the Athenaeum with only the indications of the SC and SSD positions, as well as the country of origin of the declarant, with the intent of providing information for the subsequent request for selective procedures for the recruitment of external professors from the Department.

The expression of interest does not give the right to admission to procedures for access to the qualifications of teaching staff at the University of Palermo.

5. Methods of data processing

The personal data of the data subject are processed with the support of computer and paper means. The Data Controller takes appropriate organizational and technical measures to protect and ensure the confidentiality of the personal data in its possession, in particular against loss, theft, as well as unauthorized use, disclosure or modification of personal data. The Data Controller does not use automated decision-making processes, including profiling, in compliance with the guarantees provided for in Article 22 of the EU Regulation.

6. Legal basis for processing and nature of conferral



Personal data are processed in accordance with paragraphs (a) and (e) of Article 6 of the EU Regulation.

The provision of personal data is optional in nature: in case of failure, partial or inaccurate provision of data, or in case of failure to provide consensus, it will not be possible to follow up this expression of interest for the pursuit of the indicated purposes.

7. Data recipients

To the extent pertinent to the stated purposes of processing, the personal data of the data subject are processed by the internal staff of the Data Controller, authorized and instructed by the Data Controller on security and proper use of data in compliance with current regulations.

8. Retention of data

Personal data are kept in the Owner's computer files for a period not exceeding the achievement of the purposes for which they are processed or until any request for deletion is provided by the data subject. The Data Controller carries out data processing according to the principles of adequacy, relevance and minimization of data, periodically checking the necessity of their storage.

9. Rights of the data subject

The data subject may exercise the rights provided in Articles 15 et seq. of the EU Regulation, such as the right of access, the right to rectification or integration of their data, the right for cancelling (right to be forgotten) and to restriction of processing, and the right to data portability, under the conditions and within the limits indicated by the EU Regulation. The data subject has the right to object at any time to the processing of his/her personal data, in accordance with Article 21 of the EU Regulation. The data subject may lodge a complaint with the Data Protection Authority.

10. Ways of exercising rights
